MATCH PLAY SCORING

Each team will have two pairs from each division and they will play against a pair from one of the other teams that are in the same division. Example Palmer pairs play against Palmer pairs, and so on. Each foursome will contain 3 matches, each worth one point. Two singles matches and a team (better ball) match.

Singles Matches -- Handicaps will be netted against each other so the higher handicap player will receive strokes on the handicap equal to the difference between his handicap and the lower handicap player's handicap. For example, Player "A" is a 10 and Player "B" is an 18; Player "B" will receive 8 strokes on handicap holes 1 through 8.

Two-Man Better Ball Match -- Handicaps will be netted off of the lowest handicap player and the remaining three players will receive strokes on the holes equal to the difference between their handicap and the lowest handicap player's handicap. Example as follows:

| | Course | Strokes |
|--------------------------|------------------|----------|

| Player "A" | 3 | 0 |
| Player "B" (A's partner) | 8 | 5 |
| Player "C" | 19 | 16 |
| Player "D" (C's partner) | 22 | 19 |

There are a total of 27 points available; each Division has the possibility of winning 18 points. A tie in the overall competition will be decided by a sudden victory Better Ball playoff between the #1 ranked Trevino team from each of the teams tied at the end of regulation play. Strokes to be awarded as described in the Two-Man Better Ball Match above.

- 1. USGA rules apply except as modified on the scorecard and as modified on the Rules Sheet. All rules applicable to Match Play are in force.
- 2. Honors on the tee are determined by the previous holes result of the Better Ball Match.
- 3. You may concede putts to your opponent if desired. Scores for handicap purposes will assume the next shot was holed.
- 4. Partners may assist each other with club selections, yardage, and reading breaks on greens. In consulting with your partner, please be aware of the effect on your pace of play.
- 5. In the interest of speed of play, you are encouraged to pick up and concede a hole if you are obviously going to lose that hole. For example, your opponent is on the green in regulation and you have just put your third ball out of bounds, concede the hole and move on.
- 6. Players are asked to remain in the practice area until the tournament has concluded. You will be able to cheer your teammates on as they finish their rounds.

Closest to the Pin: Palmer #7 Trevino #9 Player #17

From the Scorecard:

- Fescue or any high grass is defined as a penalty area
- Penalty areas are defined by red stakes (If there are no red lines/stakes marking the edge of the penalty area near water, the boundary of the penalty area is where the high grass / fescue meets the rough.)
- Out of Bounds is defined by white stakes

Hole 10 – There is a roped off area on the right side up towards the green that has keep out signs. It should be played as Ground Under Repair if your ball is within this area and still in bounds. Free drop, 1 club length from nearest point of complete relief outside the roped off area.

Players to return to practice area to submit scores after match is concluded.
