

NIMAGA C&G Match Play Tournament

15th Annual Edition

General Information

- Open to NIMAGA second (and older) year members (first year members are ineligible).
 - a. C&GMPT matches will NOT be allowed during regular NIMAGA stroke play events.
- Season long single elimination Match Play Tournament in which opponents will mutually arrange the course and time within each month to play their match, with the winner advancing to the next round. The finals will be played in September or October at a premier upscale course in Northern Illinois. The two semi-final winners from each division will play for their respective division Championship and runner-up. Golf and cart will be provided gratis for the final round matches.
- Since the C&GMPT is a sanctioned NIMAGA Tournament, the four semi-finalists will qualify for the 2023 • NIMAGA Players Championship.
- Your posted USGA Handicap Index (through the CDGA www.cdga.org) on the day of each match will be used for that match. The handicap index is then adjusted for the course you play based on the tees you use. The higher handicap will receive the differential on the lowest handicap holes. Players will be required to have posted the same minimum number of rounds with GHN required by NIMAGA for the corresponding monthly tournament. See "Rules and Eligibility" on www.nimaga.org for further clarification.
- A field of 48 to 64 would allow for five rounds in two divisions (high and low) commencing in April. A field of over 64 would require an additional "play-in" round. Any first round byes and all "play-in" round participants will be determined by the date that your registration form and entry fee are received. Should there be an opening for any reason prior to the second full round of play, re-entry after a loss (with an additional \$25 fee) will also be based on the date of entry. We will do everything possible to avoid first round and "play-in" round byes. Entry fees are non-refundable unless you or the tournament committee are able to get a replacement player who meets all the qualifications.
- A one-time **\$25** entry fee will provide the following minimum incentives for a field of 64:
 - * The two semi-finalists from each Division will qualify for the NIMAGA Players Championship.
 - * **\$32** NIMAGA Certificate to all 2nd round winners (not including "play-in" round).
 - * Additional \$38 NIMAGA Certificate to all quarter-final winners.
 - * Additional \$49 NIMAGA Certificates to all semi-final winners.
 - Gratis Golf and Cart for the final four playing the final match in their respective Divisions.
 - * Additional \$64 NIMAGA Certificate & Plaque to the two Match Play Champions.

Note: Winnings are from 2021. NIMAGA Certificate values and NPC gualifiers could change depending on the field size.
